He manages networks of arms dealers operating both inside the country and abroad. He works with various individuals, including snipers and businesspeople responsible for managing the funds used to purchase the weapons.

Case statement	Bashir is the overall commander of the Al-Shabaab forces and serves as the chairperson of the Military Council, managing its finances and military resources. He is the mastermind behind numerous planned attacks targeting innocent civilians. He has directly organized bloody battles that have led to the spread of protracted conflict, widespread displacement, and severe economic and social devastation. His reprehensible actions are emblematic of the massacres, chaos, and enduring instability that the group has inflicted on the Somali people.

<b>Case statement</b>	Mohamed Yare is the chief judge of Al-Shabaab and is responsible for determining the group's distorted court rulings, through which harsh punishments are imposed to suppress individuals who oppose the group's orders or are accused of religious violations. He plays a significant role in intimidating the population and reinforcing the group's iron-fisted control over the areas it administers.

He also played a direct role in the extortion and economic coercion imposed on the Somali population, forcibly extracting assets and businesses under the guise of illegitimate “zakat.” The funds he collected were used to finance the group’s ruthless activities, making him directly complicit in the destruction of the community’s livelihoods.

<b>Case statement</b>	Yusuf Kabakutukade is the governor of the Middle Shabelle region and administers a system of repression and coercion used to abuse the population of that region. He enforces unjust orders through intimidation, extortion, and punitive rulings aimed at raising funds for Al-Shabaab and suppressing local residents. He plays a significant role in fragmenting the community and undermining the foundations of civilian life.
